From the Vicarage

Dear Friends

I seem to have written to many of you a number of times in recent weeks. Those of you on the Church Electoral Roll will have received an invitation to reapply, as we draw up a New Roll in 2025, and those who are part of our stewardship scheme should have received a letter of thanks, along with information about the continuing financial challenges we face.

These things are important, and I make no apology for them. It is important that the Church is well governed and that there is the opportunity to vote for those who represent you on the Church Council, and to hold them to account at an Annual Meeting.

This year our Annual Meeting will be on Tuesday May 27th at 7.00 pm in St Chad's, and we would love to see you there. It is also important to be honest and transparent about the financial challenges we face and our dependence, in recent years, upon legacies to balance our books. Without such income, which of its nature is very unpredictable, we face a deficit in 2025 of £30, 000. If these are important matters, so too is the appointment of a new Archbishop of Canterbury, and you can read elsewhere in The New Sentinel about the process involved. I will follow that process with interest and pray hard for the person appointed, to what is a challenging, and in many ways, an unenviable role.

Yet, as Easter approaches, we are reminded that all such matters must find their place in the wider context and the bigger picture of a world transformed by the Cross and the Resurrection. As St Paul reminded the Corinthians, "If Christ has not been raised, your faith is futile and you are still in your sins". Church order, church finances and the appointment of Archbishops demand our attention, but they must never distract us from the mystery of faith,


Parish Church of St Chad and St Hilda's Charity Number 1131531 "Christ has died, Christ is risen, Christ will come again!".

There are books which seek to explain the mystery for those whose intellectual scruples leave them unwilling to commit, but for me Easter is a time to rejoice in the mystery.



Year 3: How did Jesus change lives?

In Year 3 this half-term, we have been learning all about Jesus and the way in which he changed the lives of the people he met. We began by exploring what change means to us, discussing changes that we have experienced and whether we thought change is always good or bad. We discussed how we might feel about a new arrival in our family or a special guest to our home, what might we do to prepare? Some of us thought that we should give them gifts to make them feel welcome, others believed that we should simply treat them with kindness.

Following this we explored the Nativity story, discussing how

Jesus was welcomed into the world and the ways in which he changed the lives of Mary and Joseph.

Then we went on to explore the Gospels, reading through and discussing 'The Calling of Matthew' (Matthew 9). We made lists of what we believed was important to Matthew before and after he met Jesus. We went on to discuss the quote 'People who are well do not need a doctor, but only those who are sick... I have not come to call respectable people, but outcasts,' exploring the idea that Jesus came to Earth to help those who need it. We explored this idea further by looking at the story of Zacchaeus (Luke 19), even though Zacchaeus was disliked by the people of Jericho,

Jesus joined him and helped him to find the path to repentance; 'Salvation has come to his house today, for this man, also, is a descendant of Abraham'. Finally, we explored the story of the Rich Young Man (Matthew 19) and spoke about the idea of

sacrifice in service of others. We discussed whether we would make that same sacrifice if it meant truly living a good life.

Following this we brought the lessons Jesus taught us about sacrifice and service into the modern day, discussing ways in which Christians today change the lives of the people around them. The children explored Christian Aid and the life of Mother Theresa, researching and creating their own biographies, looking at Christian charities and reflecting on the ways in which they embody our Christian Values.

WHO CHOOSES THE ARCHBISHOP OF CANTERBURY?

Late in 1902, the then Archbishop of Canterbury died in office. It seemed to most that the only possible candidate to succeed him was the Bishop of Winchester, Bishop Randall Davidson. The then UK Prime Minister, Arthur Balfour, wrote to Bishop Davidson: "I mean to propose your name to His Majesty the King (King Edward Parish Church of St Chad and St Hilda's

VII)" he wrote. "From conversations I have had with him, I have no doubt that he will agree". HM the King did agree. And so, without too much delay, it came about that Bishop Davidson became Archbishop of Canterbury.

120 years on, many wish that the question of who is to be the next Archbishop of Canterbury could be decided so speedily in our day. For at least the last 50 years it has been slowly opening up its process for choosing Diocesan Bishops. The King nowadays stands back from the process. There is widespread consultation with the Diocese in question. A body is established - called a Crown Nomination Commission - which balances representation from the wider Church of England and from the Diocese whose Bishop is to be appointed. That body meets several times. They deliberate carefully and they pray intensively. Possible candidates are interviewed.

It is an open, collaborative process. But such processes are by their very nature slow.

In many ways the process for the appointment of Archbishop of Canterbury mirrors the processes for the appointment of any diocesan Bishop. But there are more interests to consider – such as those of the Diocese of Canterbury, the wider Church of England, the world-wide Anglican Communion in which the new Archbishop will pay a leading part - and so inevitably the Commission working on the appointment will be a more complex body with a need for more prolonged discussion. The Commission is comprised of:

The Chair (a layperson), appointed by the Prime Minister. In this case, it is to be Lord Evans of Weardale; The Archbishop of York; A Bishop of the Church of England; Three representatives elected from the Diocese of Canterbury; Six representatives (three clergy and three lay) elected by the General Synod of the Church of England; Five representatives from other churches in the Anglican Communion - one each from Africa; the Americas; Middle East and Asia; Oceania and Europe.

Before the Commission meets the Church of England will lead a consultation process to determine the needs of the diocese, the Church of England and the Anglican Communion. The Commission then deliberates.

At the end of the process, if all goes well, a name emerges to be passed to the UK Prime Minister and then for the Monarch's agreement. Once The King approves the chosen candidate, the UK Prime Minister's Office will announce the name of the Archbishop-designate. Given the number of interests which need to be held in balance, it is not surprising that this will not be a speedy process.

However, the public consultation is already under way. All are welcome to make their own input to this by writing to Canon Stephen Knott, The Archbishops' Secretary for Appointments, Canterbury Crown Nominations Commission (CNC), Lambeth Palace London SE1 7JU, GB An online consultation form is also available by going to this address and then following the relevant links:

Representations need to be in by March 28. It is all so different from how it was in 1902! We each of us have the opportunity to contribute to this process of discernment of who it is that God is already calling to be the next Archbishop of Canterbury. Above all, it is important that we continue to pray mightily for a good appointment at the end of this process. Here is the prayer that the Church of England is offering for us to use at this time:

Heavenly Father, shepherd of your Church, send us a faithful pastor to lead with wisdom, courage, and love, proclaiming your Gospel, celebrating the sacraments, and guiding your people in unity and truth. Strengthen your Church, we pray, and direct us in your ways, through Jesus Christ our Lord. Amen

Christian Aid Week 2025 : 11th – 17th May

** 7 Days to Make a Difference **

Every May, churches across the UK and Eire host a huge range of fundraising events, making Christian Aid Week one of the biggest acts of Christian witness in the British Isles.

Will YOU join us. It is only TOGETHER that we can beat extreme poverty and give people hope for the future. Christian Aid Week celebrates 80 years of working to give people hope. This year targets the work in Guatemala, a country dealing with immense challenges: In spite of half the population working in agriculture the country is a hunger hotspot with one of the highest rates globally of stunted development in children. It is one of the ten countries in the world rated most vulnerable to climate emergencies.

i. This year Christian Aid Week starts with our Coffee Morning at the Methodist Church Hall on Saturday 10th May, 10 – 12noon. Tickets are £2 each. There will be cakes and plants, bric-a-brac, and a raffle. Contributions can be collected (call me) or brought on the day. ii. At St Hilda's there will be a Noisy Collection on Sunday 11th May. I know there is not as much change about but if you have been collecting any please bring it to church on that Sunday. Paper Money will still be acceptable!

iii. I am planning to walk 100 miles during May. Again! This walk is a sponsored challenge. It is a cumulative walk. That is, wherever I walk each day adds to the total. I will be happy to receive donations for my challenge. I shall put a form out at the back of both our churches.

iv. Everyone will find an envelope in their weekly newsheet, some of you may get one through your door during Christian Aid Week. There will be envelopes at the back of St. Hilda's church, also at St. Chad's and St. Annes. Please pick one up to make a donation. If you feel able, please think about taking envelopes to deliver on your road, or to your neighbours.

It is up to you whether or not you collect them but please let people know where donations can be taken.

v. There will be a manned table in the Teanlowe during Christian Aid Week giving you and any passers-by an opportunity to donate, and those with envelopes a focal point for delivery.

Remember that donations can be made by cheque, made payable to Christian Aid. If you are willing to Gift Aid your donation, please make sure you have given your name and address. If you pay tax it is a very worthwhile thing to do as it adds 25percent to your donation.
